



Three men jailed after 'cat and mouse' car chase deaths



Three men involved in the deaths of another three people after a "cat and

mouse" car chase have been jailed.

Ali Hassan, 22, Abdul Hussain, 25, and Bader Nokhas, 25, were said to be driving "stupidly" on London's North Circular in Enfield in December 2013.

Hassan's Vauxhall Astra crashed into a Subaru Impreza, which careered out of control into a lorry.

Jawad Qureshi, 28, and his passengers Toheed Rubani, 34, and Haider Qureshi, 28, died in the crash.

Hassan, of Stonebridge, London; Hussain, of Edgware, London; and Nokhas, of Stanmore, Middlesex, pleaded guilty at the Old Bailey last year to careless driving.

On Friday, they were each jailed for nine months and disqualified from driving for 19 months.

The court heard the convicted men were, on average, all speeding up to 18mph over the limit.

Witness Ben Sheybany described the way they were "chasing each other" as "stupid".

Judge Noel Lucas said: "Playing games on a public highway is simply not to be tolerated."

He said the crash could only be described as "horrific" and had a "dramatic" ripple effect on the lives of the grieving families.

Boy racers have been jailed for nine months for the horror crash that killed three people when the souped-up car they were travelling in lost control during a game of 'cat and mouse'.

Jawad Qureshi, 28, was at the wheel of his high powered Subaru Impreza when it clipped the Vauxhall Astra being driven by Ali Hassan, 22, as they raced back from an event where car enthusiasts were showing off their vehicles.

Mr Qureshi, along with his uncle, Haider Qureshi, 28, and friend Toheed Robani, 34, were killed when the car twisted in the air, then smashed into a Warburton's bread lorry before bursting into flames.

Their injuries from the crash on the North Circular near Arnos Grove, which happened shortly after midnight on 23 December 2013, were so severe that investigators initially had to identify their bodies by their bank cards.



The Subaru had been travelling 'in convoy' with Hassan's Astra as well as the VW Golfs being driven by Bader Nokhas, 25, and Abdul Hussain, 24.

Hassan, Nokhas and Hussain have all admitted causing death by careless driving of their three friends.

Today, they were jailed for nine months each and banned from driving for 19 months by a judge at the Old Bailey.

Sentencing, Judge Noel Lucas said: 'It seems to me the courts must make it clear to young men who drive cars, that cars can, if not respected, act as significant weapons and that's what happened on this occasion.

'The courts must make it clear driving on public roads is a serious business and playing games when driving cars at speed will simply not be tolerated..'

The judge said the bad driving of each of the defendants contributed to the deaths of the three victims.

But he explained that Jawad Qureshi's driving was also partly to blame.

'The manner in which the four cars were being driven has been described as playing cat and mouse game,' said the judge.

'The cars were speeding up, slowing down and changing lanes, and in short jockeying for position.

'All four cars were being driven significantly in excess of the speed limit..'

Judge Lucas said: 'The only way to describe the resulting collision is by the word 'horrific' and very sadly the three individuals were killed instantly.'

He added: 'I fully accept not one of you intended the results that occurred to occur, I fully accept each one of you has suffered hugely and the consequences of these events and the repercussions have been catastrophic for the families of the deceased, your families and indeed to the third parties.'

The three men waved sadly to their relatives in the public gallery as they were led away.

During the inquest, witnesses to the crash described seeing 'two blue flames' shooting out of the exhaust of one of the vehicles as they changed lanes and altered speeds as if they were chasing each other'.

Prosecutor Tom Little said: 'It appears that all of the vehicles went to an event in Enfield where various car owners and enthusiasts were showing off their vehicles and it is what happened on the way back from that, that brings these three defendants before the court.

Witnesses saw four vehicles - a Vauxhall Astra, two VW Golfs and the Subaru - travelling above the speed limit and weaving in and out of traffic moments before the crash.

The court heard the Subaru clipped the Astra and was launched over the central reservation before colliding head on with the lorry travelling in the opposite direction.

The three victims were pronounced dead at the scene and a post-mortem examination found they had all suffered multiple injuries 'consistent with a high energy road traffic collision'.

No charges were brought over the crash until evidence of the crash was heard at an inquest into the deaths at Barnet Coroner's Court.

The coroner suspended the case and referred the case to the Crown Prosecution Service before Nokhas, Hussain and Hassan each admitted three counts of causing death by careless driving in November last year.

They will be sentenced at the Old Bailey today.

Alternative charges of causing death by dangerous driving, which they denied, were ordered to lie on court file.

Hassan was driving a high-performance Vauxhall Astra, Nokhas was at the wheel of a black VW Golf and Hussain was driving a grey Golf.

All of them had attended an unofficial gathering of car enthusiasts at the McDonald's on the A10, in Enfield, earlier that evening.

Witnesses told the inquest the Subaru - a model which has appeared in several Fast & Furious movies - appeared to be 'racing' the three other cars at the time of the accident.

Hassan, who was uninsured, insisted he had been travelling at around 35mph when the Subaru clipped his car.

Anil Makwana had been travelling westbound on the North Circular when he was undertaken by a black golf with a double exhaust and blacked out windows.

He said he saw two blue flames shot out of the back of one of the Golfs and it suddenly crossed from the inside lane to the outside lane, causing Hassan's Vauxhall Astra to brake suddenly.

'The three cars were racing to get into the third lane, weaving in and out of the traffic, and then that's when they were too far ahead for me to see,' he told the inquest.

'The Golf cut across into the third lane, and the vehicle behind the golf clipped the Subaru, then the Subaru was literally in the air.

'It flew into the air on to the opposite side of the road where the Warburton's lorry struck the Subaru.'

Mr Makwana witnessed the lorry driver desperately trying to put out the flames, but said he could see immediately the three men were dead.

A second witness Kunal Joshi, who did not see the actual crash, said he saw a number of high-powered vehicles speeding on that section of road that evening.



He said in a statement: 'I've never seen vehicles going at that speed in my life.'

'I commented to my wife that someone is going to get killed tonight the way they are driving,' he added.

Claire Gomes Ait-Younes had been driving back from the O2 Arena with her sister when a number of cars, including two BMWs and a Honda, undertook them at great speed.

She said a large number of cars had congregated in a car park next to the North Circular, and told police she thought it had been some kind of meeting.

Thomas Mangold who had been driving home with his wife on the night of the accident, said he saw cars 'weaving in and out of view either racing or chasing.'

He added: 'In my view their behaviour on the road was very dangerous.'

Seconds later he saw a car on the other side of the road in flames.

Neos Sofianou, 72, who lives opposite the scene, said at the time of the crash: 'I ran to see what was happening and when I saw the car was on fire I tried to help with fire extinguishers.

'But we couldn't get close enough to the car because of the flames and it was just so hot. It really was a terrible sight because we knew they were in the car and knew they were burning.'

Mr Sofianou's son Marios Sofianou, 47, said: 'We had to watch the three of them burn, it was horrible.'

The funeral of Jawad and Haider Qureshi at Harrow Central Mosque was attended by 2,000 people.

Haider's uncle, Mohammed Abdullah Qureshi said: 'Haider was a very hard working and honest boy.

'He worked at Halfords and was supposed to be the manager soon because he was so hardworking but unfortunately it ended like this.'

The father-of-one was buried alongside his nephew, Jawad, who was a car park manager at Heathrow Terminal Three.

Mohammed Qureshi said of Jawad: 'He was an exceptional boy, but unfortunately the time had come and he had to go. He was supposed to be getting married in a couple of months.'



Speeding drivers are facing jail after their "cat and mouse" car chase caused the deaths of three young men in a head-on collision on the <u>North Circular</u>.

Ali Hassan, 22, Abdul Hussain, 25, and Bader Nokhas, 25, were said to be driving "stupidly" in north <u>London</u> as they returned from a motor enthusiasts' event in <u>Enfield</u> on December 23 2013.



Just after midnight, Hassan's Vauxhall Astra crashed into the victims' Subaru Impreza, which careered out of control across the central reservation and into the path of an oncoming Warburtons' bread lorry.

Last December, the defendants pleaded guilty to causing the deaths of the driver Jawad Qureshi, 28, and his passengers Toheed Rubani, 34, and Haider Qureshi, 28, through their careless driving.

As they appeared to be sentenced, the Old Bailey heard the victims had been out celebrating young father Haider Qureshi's first pay cheque in his new managerial job when tragedy struck.

Just before the crash, the defendants had been driving in convoy some two seconds apart in two Volkswagen Golfs and a Vauxhall Astra.

They were all speeding on average up to 18mph over the limit and witness Ben Sheybany described the way they were "chasing each other" as "stupid".

After the crash, Hussain drove on and later lied to police claiming he was not behind the wheel of one of the Golfs as he had no insurance.

Judge Noel Lucas QC said there had been a "dramatic" ripple effect on the lives of the grieving families.

Reading from statements, prosecutor Tom Little outlined the grief caused to the families of the victims, who attended court.

Mr Rubani's brother Waheed said he was a "loving person who looked out for everyone and anyone".

Jawad Qureshi's brother Umair spoke of the devastating impact on their parents and described his mother as a "changed person".

PUBLIC SPACES PROTECTION ORDER NUMBER 2 of 2021 (the "ORDER")

WITHIN THE LONDON BOROUGH OF ENFIELD, THE A10, ENFIELD RETAIL PARK EN1 1TH, THE A406, RAVENSIDE RETAIL PARK N18 3HA, TESCO CARPARK IN GLOVER DRIVE N18 3HF, MILLMARSH LANE EN3, RIVERWALK ROAD BUSINESS PARK EN3 7QN AND THE COLOSSEUM BUSINESS PARK EN1 3FD

This Order may be cited as the London Borough of Enfield, Public Spaces Protection Order Number 2 of 2021.

The London Borough of Enfield exercises its powers under Section 59, 64 and 72 of the Anti-Social Behaviour, Crime and Policing Act 2014 ("the Act") and under all other enabling powers, hereby makes the following Order:

- This Order shall come into operation on 4 February 2021 and shall have an effect for 3 years thereafter, unless extended by further Order under the Council's statutory powers.
- 2. This Order relates to the parts of the London Borough of Enfield, as shown filled in or outlined in blue on the attached plan in Appendix 1 ("the designated area").
- 3. The Council is satisfied that the conditions set out in Section 59 (2) of the Act have been met. Namely, that the following anti-social behaviour and criminal activities have been carried out within the designated area:

Participating in vehicle cruising activity as a passenger or driver of a vehicle, and/or congregating in the area to spectate cruising activity to include cars, motorbikes and mopeds or other vehicles

These activities have had a detrimental effect on the quality of life of those in the locality, and it is likely that the activities will be carried out within that area and have such an effect.

4. The Council is also satisfied that the conditions set out in Section 59 (3) of the Act have been met. Namely, that the effect or likely effect of the activities is, or is likely to be, of a persistent or continuing nature and that these activities are unreasonable and justify the restrictions imposed by this Order and that it is in all the circumstances expedient to make this Order for the purpose of reducing crime and/or anti-social behaviour in a public place.

PROHIBITIONS:

 No person shall participate in vehicle cruising activity as a passenger or driver of a vehicle and/or congregate to spectate vehicle cruising activity within the designated area in the Public Spaces Protection Order.

Vehicle cruising is activity that a reasonable person would consider to be 'car cruising' such as speeding, driving in convoy, racing, performing stunts, sounding horns (as to cause public nuisance), revving engines, wheel spins etc. using cars, motorbikes, mopeds, vans, trucks or lorries or other vehicles.

AUTHORISED PERSONS:

An authorised person could be a Police Constable, Police Community Support Officer or Council Officer, and must be able to present their authority upon request.

FIXED PENALTY NOTICES AND OFFENCES:

- 1. It is an offence for a person without reasonable excuse to engage in any activity that is prohibited by this Order.
- In accordance with section 67 of the Act, a person found to be in breach of this Order is liable on summary conviction to a maximum penalty of a level 3 fine or to a Fixed Penalty Notice up to £100.

APPEALS:

1. In accordance with section 66 of the Act, any interested person who wishes to challenge the validity of this Order on the grounds that the Council did not have the power to make the Order or that a requirement under the Act has not been complied with may apply to the High Court within six weeks from the date upon which the Order is made.



There are no preventative measure to stop vehicles gaining access to Hoe Green Park. This space is also used by dog-walkers and by children playing. I find it highly frustrating that people can so brazenly ignore the law, without any fear of consequence. All of the bikes I have seen either do not have number plates (unlicensed vehicles) or are too far away to see them clearly. I have recorded videos of these motorcyclists on several (but not all) occasions but e-mail file attachment sizes do not permit me to share them with you. If there is a secure, private means to send these video files to those interested in dealing with this, please let me know. May I also add that I cannot have my windows open (without enduring the noise full force) during the summer months because the motorbikes are so loud as they pass my window. This is not a case of them going up and down a few times and leaving, these people will often speed up and down the green, popping wheelies and drag racing one and other for hours at a time. The only way I can describe what they are doing is "how to make a lot of noise". Tyres screeching, loud engine noises and a lot of extremely loud banging, like someone was gun shooting or like the fireworks on Bonfire Night. Often, but not every time, there is also a very loud music, with a lot of bass, sometimes so intense that the air and the windows vibrate. Overall the noise is so horrendous we can barely hear the tv, even with volume up – and that is if all the windows in the flat are closed! It is just unbearable. I am making this statement at the request of the London Borough of Enfield in support of an injunction to tackle "Car Meets" which occur on the Borough, to the detriment of the local residents.


I have been a Police Officer for twenty (20) years with nearly all my service being in Haringey and Enfield. My current post, which I have occupied since June 2022 is as the Neighbourhood Policing Team (NPT) Inspector, responsible for running the ward teams which undertake community Policing across the twenty five (25) wards in Enfield. My previous post, also in Enfield, was as the Operations Leader in Edmonton, and I have previously served on Response Team in Enfield as a Sergeant, that being the team responsible for responding to emergencies.

I have also been a resident of Enfield for nearly 20 years. I was aware from my previous postings that there were regular car meets in car parks and open spaces within the Borough. These typically generated a significant number of calls which the Police would respond to, though as there were frequently many dozens of cars present there was a limited impact on the events of Police attendance by the Response team.

As a result of the complaints generated the NPT started an Operation named Operation Ghostfreak, run jointly with the Roads and Transport Policing Command (RTPC) in an effort to tackle these meets and reduce the associated Anti Social Behaviour (ASB) given the impact on residents of the noise, and associated pollution. This operation pre-dated my posting in NPT but was started by PS Lynsey MURPHY in NPT, who then passed the running of the operation to PS Billy CROSBY. PS Mark WELLS ran the operation from RTPC. To staff these operations my NPT are abstracted from their other duties to specifically run these operations, and whilst clearly in the public interest do have a knock on effect in the wider sense considering our parlous staffing levels and myriad other demands.

They (The officers named above) have also provided statements and have used existing legislative powers from Anti Social Behaviour and Road traffic legislation to prosecute and warn the attendees of these meets. Despite dozens of court summons, arrests and vehicle seizures there are still regular meetings which tend to gravitate towards Enfield. As an NPT we have assisted the council in placing target hardening measures at one of the most frequent venues (Concrete blocks in the car park) at the retail park on the A10, and have run separate patrols under the banner of Operation Coal to try and deter and disperse meets but Witness Signature:

they, whilst effective, have only a limited impact as we have no legal powers beyond a dispersal zone to prevent these meetings taking place and once they are occurring, limited staff to disperse them on an ad hoc basis.

In October 2022 I attended two public meetings, one in Bush Hill Park and one in Grange Park. Both of these meetings were well attended with dozens of residents who described in detail the negative impact that these car meets have on their personal wellbeing and quality of life. They described how the noise from revving engines, backfiring exhausts (A lot of the cars have specially modified exhausts to make the car sound louder, though I believe there is also said to be a marginal increase in performance of said vehicle) and screeching tyres would keep them awake at night. They described how even in the hottest weather they were unable to leave their window open as the excessive noise disturbed them so much they were unable to sleep.

As a local resident who lived in Bush Hill Park I can testify that despite my home at the time being nearly 1000m as the crow flies from the A10 and the retail park I had to keep my windows closed all year round especially at weekends, to avoid hearing the noise which kept me awake at night, and the lack of sleep this engendered was particularly trying as a shift worker. Likewise the noise from backfiring exhausts would echo across the area and sounded like news clips from a warzone. This would wake me up in the night and would often continue until after midnight at weekends. This was not a unique experience for residents, and as the attendees would testify at the meetings, especially those who lived closer to the A10 than I did, the sound and disturbance was, and still is, intolerable. The people that attend the car meets are apparently oblivious to this disruption, and whilst there was a person seemingly from "A10 car meets" (an internet/Instagram group which encourage attendance of these meetings and draw them to Enfield), they were unwilling to countenance that they were responsible for causing said distress. They claimed improbably that they discouraged the behaviour and ASB that the residents complained of, but their own Instagram feed and evidence collected by my colleagues during proactive operations demonstrated that at all of these meets there was dangerous and anti social behaviour, and that the meetings were the principle cause of the ASB and distress complained of by local residents.

On a wider point regarding public safety, there have so far this year been two notable incidents which I consider are linked to the wider problem in Enfield caused by these sorts of meetings which seem to engender indifference to other members of the public or road users. In the first on the 9th of January 2024 a female was struck and killed crossing the A10 at a pedestrian crossing by a vehicle which was according to witnesses racing a second vehicle. Whilst I acknowledge that this is not linked to car meets per se the fact that the A10 and the Enfield area are now synonymous in the eyes of car enthusiasts with driving fast, dangerously, in an anti social manner and "showing off" high performance vehicles is I believe a contributory factor. This case is yet to be disposed of judicially though the driver of the vehicle concerned was arrested after leaving and subsequently returning to the scene.

At a car meet on the 28th January at Innova Science Park in EN3 there was an accident whereby a car apparently skidding around a roundabout lost control striking and injuring a pregnant female. The female was taken to hospital and was thankfully not seriously injured. The driver of the vehicle was arrested and their car seized on account of the fact it had

previously been issued a warning under S59 of the Police Reform Act due its anti social use, but the attendees of said meet did not co-operate or provide statements to assist in the prosecution of the driver. At this point the case is not yet disposed of judicially. (CAD 6950/28JAN24 refers). Another meet which was attended by Police on 3rd February 2024 resulted in dozens of Community Protection Warnings being issued to vehicles and their owners. Of note one vehicle had apparently travelled from the Midlands to attend.

From a Policing perspective I believe that an injunction banning these meetings from occurring in Enfield with suitable enforcement powers would be hugely beneficial to both public safety to other road users and also dramatically increase the quality of life for the many thousands of residents in Enfield that live near the A10, the Innova Science Park, or indeed any open space which affords an opportunity for these meets to take place. The problem and impact on local residents has had a deleterious effect on their quality of life for many years, and engagement with the attendees and enforcement by Police when they occur has failed to eradicate the problem or provide a long term solution. There is nowhere in Enfield where these meetings could occur without having a negative impact on the local residents, and the attendees of the car meets, who are not seemingly residents of Enfield for the most part, are totally indifferent to the effect that their behaviour has on the populace. Whilst I make this statement in an official capacity as the NPT Inspector I myself have been impacted by these meetings and the noise and air pollution that they cause, but given my responsibilities for crime and disorder in Enfield it would be inappropriate to deploy my resources, such as they are, to exclusivity of other issues of public safety, and that is why I

I wish to describe and explain my experience with the car meetings that occur in the Borough of Enfield. Since 2020, I have been the supervisor for the Safer Roads Team, a small team of officers tasked with working with specialist units, local neighbourhood teams and the community to stop these events. I have been a police officer for nearly 40 years, working in several police services which include Kent Police, Canadian Police, British Transport Police and Metropolitan Police. I am advanced police driver. In the context of this statement, a vehicle meeting event means a gathering of 15 or more vehicles where the main purpose of the meeting is to encourage dangerous, careless, or inconsiderate driving in a manner likely to cause harassment, alarm or distress to the public by its anti-social manner, or where such driving is expected to take place. A vehicle meeting is not a static meeting for enthusiasts where no anti-social behaviour takes place or a social gathering in vehicles with anti-social behaviour or other offences not linked to driving standards. These meetings are organised online and are challenging to police because they are often arranged at short
notice, normally the time and location is published one hour before the event takes place. They also occur across London and in the Home Counties. The number of participants varies, but we often see 300+ vehicles at any one time. The organisers will encourage large numbers to attend, some of the organisers have 44,000 followers on social
media. In many cases, the organisation of the meetings takes place using private encrypted sites, which the police are unable to monitor. However, sometimes the events are advertised on open social media. The events are often live streamed and videoed for social media, they are subsequently published on Utube and Tic toc. The attendees will often drive over 100 miles to visit a location. The events are sometimes advertised as static meets meaning no stunts or drifting of cars. Other occasions, they will encourage stunts and racing at the events. Normally, all these events involve elements of anti-social behaviour. The participants will deliberately rev their car engines, burn their tyres (spinning wheels, whilst holding the vehicle static) and sound their horns. When they perform stunts such as racing and drifting (the vehicle is deliberately spinning around a circle producing burning tyre, smoke, noise), they cause major disruption to the local community. Importantly, the drifting is performed within yards of a crowd of pedestrians gathered to watch the spectacle. Some of these pedestrians will film the vehicles for social media.
The stunts and racing presents a real risk of injury and death to the people standing close to the vehicle. Many of these stunts are performed by inexperienced drivers, cheered on and encouraged by the crowd to go faster and faster. The disturbance caused to the local community is huge, the noise created by these stunts will travel considerable distances, over half a mile. The sound of the exhausts is comparable to a shotgun continuously firing in a built up area.
Many of these locations are very urban, with flats and houses close to the venue. This produces many complaints to the police and council, sometimes over 50 people will call the police in desperation for the event to be closed down, so they can sleep.
These events take place mostly at weekends late at night between 2100 and 0100, but they have occurred in the week and on Sundays, disrupting the sleep for people working in the morning. Racing is another high risk activity at Enfield. This will often involve two cars travelling together at speed on the highway or around a car park. They will not necessarily time the event, but the racing of the trace of the distribution of around obstacles. Sadly, outside London this has caused fatalities where vehicles lose control as they race past the crowd or crash into the crowd. Importantly, many crashes and near

Furthermore, it is highly likely that drivers will lose control, people taking part are often young and inexperienced drivers; many hazards are present such as enclosed spaces, roadside furniture, wet/damp roads, high speed, illegal tyres and vehicles modified for use on race circuits with no special safety equipment. They will deliberately drive within feet of a large crowd, other pedestrians and vehicles.

The drivers themselves are often easily manipulated and exploited by organisers. The car meetings are often organised by older more experience drivers who are making money by advertising their businesses, selling merchandise (t shirts) and actively encourage attendance at car meetings. For example, car modification garages (removing manufactured standard exhausts), modification outlets and some unscrupulous car engine management garages.

The Metropolitan Police is committed to supporting The London Mayor's Transport Strategy which includes the Vison Zero plan of eliminating all deaths and serious injuries on the transport network by 2041. Stopping car meetings in Enfield which encourage dangerous and careless driving will greatly contribute to road safety and support Vision Zero. Sadly, despite all our work, crashes which involve a fatality are rising in this borough, triggering more decisive action and the need for the council to seek further remedies in the law courts. I fully support the application for an Enfield Borough wide injunction to prevent these events taking place. As previously stated, the meetings will move around the Borough, in order to be effective any measures need to include the whole area of Enfield, prevent spectators from attending, drivers and passengers from participating and prevent organisers from arranging these events (on social media). Activities such as racing on the highway and deliberately performing vehicle stunts for entertainment need to be restricted in Enfield. The injunction along with the appropriate powers to enforce, would send a strong signal these events are unlawful (anti-social behaviour, Health and safety grounds and dangerous driving) and present a serious threat to public safety and disproportionately disrupt the lives of the majority of public living peacefully in the Enfield Borough.

I have been a Metropolitan Police officer since 1996 and have specialised in Traffic since 2012. I am an Advanced Police driver, Police motorcyclist, cyclist and a vehicle examiner. I hold a RoSPA certificate in Road Safety, Accident Investigation and Prevention. I am a Member of the Chartered Institute of Highways & Transportation (MCIHT) and an Associate Member of the Institute of Highway Engineers (AMIHE). I currently work as a Traffic Management Officer on the Road Safety Engineering Unit based in north London. Enfield is one of the boroughs I cover.


Prior to my current role I was on the Roads Policing Team covering north east London, including Enfield. Before joining this team I was based in Enfield between 2008 and 2012 working in various roles there. In addition to a working knowledge of the borough, I was an Enfield resident between 1991 and 2014 and still live close by.

At various times through this period I have had dealings with the anti-social driving behaviour that occurs in, or near, the north east of the borough. Especially around the A10, Great Cambridge Road. I believe the problem to have been going on since the early 2000's and there are videos showing this on YouTube dating back to 2008. This area of the borough is bordered to the north by the M25 and on the other side of that is Hertfordshire where the problem used to spread to.

The general behaviour has been pretty consistent, with Friday, Saturday and Sunday nights being the most popular. Drivers will come into the area and head for car parks in and around the Crown Road retail centres and the drive through McDonalds and KFC. Social media is then used to circulate the location of where the main meeting is and they then move to this area – often the Coliseum Retail Park car park where KFC is. Some drivers will then perform stunts while watched by many others. Participants tend to drift in and out of the area onto the

main roads where they commonly drive excessively fast and race each other. This behaviour often leads to collisions.

The first time that I was actively involved in trying to stop this was in 2012. At that time, events were focussed on the Coliseum Retail Park car park and we sought to get the owners of the site to provide security on the affected nights to restrict access by staffing the gates. The net result of this was that they moved to the Ravenside Retail Park on the A406 North Circular, and the meet got much larger as others attended from the Newham and Waltham Forest areas. There was even a mobile burger van that used to attend to provide refreshments for the hundreds of attendees. Policing it became difficult due to the large numbers and resourcing issues. At one point a Roads Policing colleague was assaulted and then surrounded by a mob while trying to deal with particularly dangerous piece of driving. In 2015, as part of a London-wide safety camera review, Transport for London (TfL) decommissioned some safety cameras along the A10. Shortly afterwards, Hertfordshire chose to deal with the problem on their part of the A10 by introducing an average speed camera system immediately to the north of the border with the M25. As part of their evidence to justify this they established that drivers were travelling from as far away as Belgium to partake in street racing on the A10. The result of the camera introduction was that anti-social driving then became concentrated within Enfield.

Between 01/05/2016 and 30/04/2019 on the northern section of the A10 there were 5 fatal and 27 serious injury collisions. This was in stark difference to the previous 3 years where there was only 1 fatal and 7 serious injury collisions in the same area.

The last of the 5 fatal collisions was on 12/11/2018 when 26yr old mother Ariola Hoxhaj and her boyfriend were racing each other southbound on the A10 well in excess of the speed limit and she crashed into a tree. The boyfriend was subsequently jailed for causing death by dangerous driving.

In response to this rise in KSI collisions an operation was launched by the Roads and Transport Policing Command, led by Superintendent Andy Cox. This was a very unusual step as, normally, for problems such as this the local borough police take the lead and request specialist assistance where needed. Supt Cox sought funding directly from TfL for a heavy Roads Policing Team presence for a year. During that operation there were 2284 total offences reported (1373 for speeding), 113 persons arrested (52 for drink or drug driving) and 171 vehicles seized for various offences. This was solely on the northernmost section of



the A10 between Lincoln Road and the M25. This level of enforcement was always known to be only for a short term as it wasn't sustainable. The cost was £126,000 in staffing alone. Supt Cox worked with TfL to get them to agree to introduce an average speed camera system between Southbury Road and the M25 at a cost of £300,000. These went 'live' in April 2020 and for their first year of operation there were an average of 186 offences a day detected. Within this year the injury collisions also dropped significantly in the area to 0 fatals and 4 resulting in serious injury. To date we have had no more fatal collisions along this stretch of road and the cameras are still active.

This is not the only engineering measure that has been introduced to try and stop the problem. Both Sainsburys and the owners of Enfield Retail Park, which both neighbour the Coliseum Retail Park, were consulted and brought in extensive measures to prevent their property from being used for the car meets. The London Borough of Enfield have also introduced measures to try and stop the anti social driving: When they moved to the area around Mollison Avenue (which runs parallel to the A10) and were using River Walk Road to perform stunts the council introduced a road surface treatment that prevents this from happening. The drivers then simply moved to another road, Lockfield Avenue, and the council then brought in some speed humps to try and stop it there, but these have proved largely ineffectual. They have been back in this area over recent months and also in nearby Solar Way which is not all council property so any engineering measures would not be straightforward to introduce. The are some potential engineering options, but, as has been shown over the years, any that are introduced will simply lead to the drivers moving to another area within the borough, of which there are many potential sites. Engineering remains an option, but it is not a solution.

Another part of my role is reviewing all fatal collisions from across London ensuring that the contributory factors are accurate for reporting to the Department for Transport. Around 50% of all fatals in London involve inappropriate speed (mainly exceeding the speed limit). For fatalities within the boroughs that I cover I also provide a report for any potential engineering measures that could be introduced to prevent them from occurring again.

This work gives me a broad overview of what types of driving behaviour are resulting in road deaths across London, and more concentrated within my area.


In 2021 there were no fatal collisions in Enfield. Since then we have seen them increasing quite significantly: In 2022 there were 6 and, to date, in 2023 there have been 10. Of these; 7

have involved driving traits typically seen by those attending the car meets and most have occurred during the hours of darkness over the weekend. Although those involved may not show on police indices as having been involved in anti-social driving at car meets, they are indicative of the type of driving behaviour which now seems to be prevalent within Enfield. Although this is seen in other boroughs of London, it is not to the extent seen here. It is also not just a recent trend.

On 23/12/2013 I was one of the officers attending a fatal collision on the A406 where 3 young men from Harrow, Jawad Qureshi, Haider Qureshi and Toheed Rohani, died on the A406 North Circular Road in Arnos Grove. They were all the occupants of a Subaru which was 1 of 4 cars that had been racing. The drivers of the 3 other cars were subsequently convicted of causing death by careless driving. As the report from the Daily Mail on 27/01/2017 regarding the convictions notes:

Hassan was driving a high-performance Vauxhall Astra, Nokhas was at the wheel of a black VW Golf and Hussain was driving a grey Golf.

All of them had attended an unofficial gathering of car enthusiasts at the McDonald's on the A10, in Enfield, earlier that evening.

Witnesses told the inquest the Subaru - a model which has appeared in several Fast & Furious movies - appeared to be 'racing' the three other cars at the time of the accident.

The behaviour seen in these fatal collisions is also seen in those of lesser severity being reported in the borough. For the past few months I have been reviewing all injury collisions that have occurred within Enfield over the weekends. The only occasions that there are not any that involve elements of driving behaviour seen at or near the car meets are when the weather has been inclement.

This past weekend (15/12 – 17/12/2023) there were 3. 2 involved vehicles at high speed crashing into the rear of innocent drivers and then failing to stop. The third one involved a performance Mercedes and an Aston Martin allegedly racing on the A406 and then colliding with 3 other vehicles resulting in the Mercedes overturning. This is pretty typical of what I have been seeing on a weekly basis. It is very possible that these types of collisions occur elsewhere in London, but within Enfield they are consistently occurring.

My Name is PC PAIGE and I have been a police officer for around three years with two of those years serving as special constable in North Area which Covers Enfield and Haringey.

During my time as a Special constable I have witness and recorded 3 separate vehicles committing road traffic offences using my police issue body worn camera.

I exhibit the below as evidence of such behaviour that has occurred in the B&Q car park.

On 01 October 2022 at 2143hrs I was on duty in police uniform in an unmarked police car where I was sat stationary observing a black convertible doing doughnuts in B&Q car park on the A10 Enfield which I exhibit at TOP/01 and the same evening at around 2154hrs I witnessed a black car driving erratically in the same car park while using BLUE FLASHING LIGHTS to imitate an emergency vehicle which I exhibit at TOP/02 then shortly after around 2200hrs on the same evening in the same car park I witnessed two vehicles side by side doing what I can only describe as a DRAG RACE from one end of the car park to the other which I exhibit as TOP/03, there were multiple members of the public with families around which endangered them and other road users attempting to use the car park for its intended purpose.

The driving that was witnessed by myself fell far below that expected of a competent and considerate driver and was also dangerous in nature.



Dear Sir/Madam

I write as a resident of Forty Hill, Enfield.

We have had problems for years as evening approaches, having to listen to cars being driven around Forty Hall car park at high speed and then the drivers performing what I am told are called "doughnut spins". The noise is terrifying. When they leave the car park, they then drive at ridiculously high speeds up or down Forty Hill.

This nightmare is more common in the summer months when the car park is open until later but it happens in the winter months too. Since lockdown last year anti -social behaviour in the car park, in the park and along Forty Hill has noticeably increased. This "doughnut driving" is a regular occurrence and has been especially distressing for us as residents in Forty Hill. When the car park is locked cars are often parked along Forty Hill, often drinking, smoking drugs and dumping their rubbish on the floor.

Last night the car park was open until gone 10pm and the sound of very loud music and "doughnut spins" from the cars in car park was terrifying, incredibly worrying and distressing for us as residents and we can hear this inside our homes. The only reason the noise stopped, was I assume because the barrier to the car park was eventually locked. A large number of people in cars and on foot then left the park. And they dropped their rubbish on the floor as they left.

The "doughnut spins" have been taking place every evening this week in the car park.

Some of my neighbours have small or young children, some are elderly, some are living alone but whatever our circumstances, we all feel thoroughly anxious, distressed and fed up with this vile, unacceptable ongoing anti-social behaviour.

I cannot even imagine what it must be like for the wildlife in and around the park.

No one has ever seemed interesting in stopping this problem and there seems to be no deterrent or consequences for the people that behave in this appalling way. I have lived on Forty Hill for 18 years and Exhibit MR1/72

have always thought it a lovely place to live. But no any longer. I want to move. I cannot bear the total disregard and lack of respect that 'visitors' to the park and area have for the park and local residents.

Over the years myself and my neighbours have complained numerous amounts of times to the police, to Enfield council and to our local councillors. Nothing has ever been done about this anti-social and extremely dangerous behaviour.

I would really appreciate if you could contact me as soon as possible regarding this continuing distressing problem.

I'm an Enfield resident living off Southbury Road, Cobham Close. I moved into my house with my husband in February 2021 and our house backs on to Southbury Leisure center and the A10.

We wanted to enjoy our first summer in 2021 in our new house, so we spent a lot of money designing and fixing up our garden. We were excited about spending time in our new outdoor space but at the beginning of July 2021 we experienced our first car meet in Southbury Leisure center car park on a Sunday (4th July) which begun at 7pm and ended at 11pm, 1 hour after the leisure Centre closes and car park should be locked. The noise was horrendous, with backfiring of exhausts, engines revving, and donuts being performed around the car park non-stop. We had no idea what this was as it was our first time witnessing it and we thought it was an event taking place. This was also taking place in the old B&Q car park near KFC at the Coliseum retail park on the A10 and I could hear cars racing on the A10 at the same time. To our disappointment this continued every Sunday through to October when the weather changed and became cold. We could not enjoy an evening in our garden throughout the whole summer without inhaling fumes coming into our garden and being smoked back inside, having to deal with noise pollution.

I logged multiple complaints on the Enfield website where I was shunned and told they were aware, yet no action taken. I then tried to contact the landlord of the B&Q car park to complain about the noise and anti-social behavior we were enduring on a weekly basis. It took me weeks to finally get in touch with a manager at the Leisure Centre who said that the car park was private property, and he would contact them to ensure the gates are locked after the Leisure Centre closes which they should have been doing every night in the first place. This did happen and we have not had to deal with car meets directly behind our house since, apart from a couple of occasions where the organiser of the meets took advantage of the gate being left unlocked.

However, the meets in the retail park worsened and this begun to impact us inside our house, unable to hear our TV, having to move into other rooms and unable to sleep. We could not even have family or friends over and sit in our kitchen because we were embarrassed of the noise over the weekend. The meets kept us awake till early hours of the morning when my partner and I get up at 6am for work. This was affecting us a great deal and the lack of sleep meant we were tired and restless at work.

I hoped that the following year would be different, and it was just a freak year of car meets. The following year 2022 we were dreading the summer and were reluctant to have our friends and family over on a Sunday evening. The car meets started again in June, earlier than the previous year and more frequent, taking place at times mid-week and on Saturdays and Sundays. At this point we were regretting moving into the house and the area. I spent these days crying as I could not enjoy my summer

evenings in the garden after working so hard throughout the year and unable to go away on holiday. At this point we considered moving only a couple of years after moving in.

There are just too many occasions to pin point dates, it happens every weekend without fail and they began earlier and finished at 1am at times. This has continued without fail every weekend and has been going in for years before I moved it. For me, it was the worst last year in the summer 2023 when I witnessed myself the disgraceful behaviour that occurred in the retail park. Masses of people, hundreds, including young children exposed to the dangerous behaviour and anti-social acts that were being committed. Dangerous and reckless driving, drugs, loud music, and car noises louder than anything I've ever heard. The landlord of the car park ignored all of my complaints and was uncontactable. When contacting the police, they did nothing because by the time I managed to get through on the non-emergency number, they had stopped. We were affected most last year when my grandparents visited from Cyprus who are in their late 80's and were staying with us (12th - 18th June). They have not been over to England for 3 years due to ill health and the first time coming back to the UK they endured this level of noise and pollution when sitting out in our garden over the weekend. My grandad could not deal with it and we all had to sit inside at the front of the house with the doors closed inside. I was devastated, mortified and furious that these inconsiderate individuals were impacting our lives so much. My grandparents found alternative accommodation for the remainder of their stay as they could not stand the noise. I recall one Sunday where I had my back door open and the fumes from the donuts and exhausts came into my house and filled my kitchen and front room, it was horrible. I am embarrassed to invite guests round to my house over the weekend so we arrange to go out in the summer months. This is not a way that I want to continue living.
