Citation and commencement

 - a) in Article 3 of that order the definitions of "Claverings parking permit" and "Claverings Schedule" were omitted.
 - b) Articles 3(4) and 10a, Articles 36, 37, 38 and 39 under the heading "Application for and issue of Claverings parking permits for use in Claverings parking places"; Article 40 under the heading "Refund of fee paid in respect of a Claverings parking permit", Article 41 under the

heading "Surrender, withdrawal and validity of Claverings parking permit", Article 42 under the heading "Application for and issue of Claverings parking permits" and Articles 43 and 44 under the heading "Form of Claverings parking permit" were omitted.

c) for Article 11 and the associated heading there were substituted the following Article and heading:

"Vouchers or season tickets to be displayed on vehicle left in a parking place

- 11. At all times whilst a vehicle, other than a solo motorcycle or a vehicle displaying a disabled person's badge in the relevant position is left in a parking place listed in Schedule 1 to this Order:
- (a) it shall display in a conspicuous position either a valid voucher or season ticket issued in accordance with the provisions of Article 14 or 25 respectively, so that all the particulars on that season ticket or permit, as the case may be, are readily visible from outside that vehicle; or
- (b) payment of the parking charge in respect of that vehicle shall be indicated by the appearance on a hand-held device of an indication that the parking charge has been paid and accepted in respect of that vehicle and in respect of the parking place in which the vehicle is left and an indication that the parking period for which payment of that parking charge has been made and accepted has not expired."
- d) for the Parking Place numbered 21. Claverings Estate in the Schedule to that Order there were substituted the item similarly numbered and set out in columns 1, 2,3 and 4 of the Schedule to this Order.
