1. An Election is to be held for of a Member of Parliament to serve Enfield North constituency.

3. Nominations papers must be delivered to the (Acting) Returning Officer at Electoral Services Office, 2nd Floor Civic Centre, Silver Street, EN1 3XA on any day after the date of this notice, on Monday to Friday 10am to 4pm (excluding bank holidays) but no later than 4pm on Friday 7 June 2024.
4. The **£500** deposit can be paid:

5. If the election is contested the poll will take place on Thursday 4 July 2024.
6. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on **Tuesday 18 June 2024.** Applications can be made online at **www.gov.uk/register tovote**.
7. New applications to vote by post, and amendments or cancellations of existing postal votes or proxy vote arrangements must reach the Electoral Registration Officer at Electoral Services Office, 2nd Floor Civic Centre, Silver Street, EN1 3XA by 5pm on **Wednesday 19th June 2024.** Applications can be made online at **www.gov.uk/apply-postal-vote**.

8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on **Wednesday 26 June 2024**. Applications for a Voter Authority Certificate can be made online: www.gov.uk/applyforphotoidtovote.
9. New applications to vote by proxy at this election must reach the Electoral Registration Officer at Electoral Services Office, 2nd Floor Civic Centre, Silver Street, EN1 3XA by 5pm on **Wednesday 26 June 2024**. Applications can be made online at www.gov.uk/apply-proxy-vote.
10. Applications to vote by emergency proxy at this election must reach the Electoral Registration Officer at Electoral Services Office, 2nd Floor Civic Centre, Silver Street, EN1 3XA by 5pm on **Thursday 4 July 2024**.
