NOTICE IS HEREBY GIVEN that to facilitate essential insert essential utility works on, Hertford Road N9 and side roads between Bury Street and Cleveland Road N9, the Council of the London Borough of Enfield have made the Enfield (Hertford Road N9 and side roads between Bury Street and Cleveland Road N9 (No. 1 (Temporary Restriction of Traffic) Order 2025, in the London Borough of Enfield under section 14(1) of the Road Traffic Regulation Act 1984. [Note: this Order continues the effect of a Notice dated 6 January 2025 given under section 14(2) of the said Act].
- 2. The effect of the Order will be to restrict all traffic, as detailed in the schedule to this notice and as and when directed by traffic signs.
