## UK Parliamentary election

1. An Election is to be held for a Member of Parliament to serve Southgate and Wood Green constituency.

3. Nominations papers must be delivered to the (Acting) Returning Officer at Electoral Services Office, 2<sup>nd</sup> Floor Civic Centre, Silver Street, EN1 3XA on any day after the date of this notice, on Monday to Friday 10am to 4pm (excluding bank holidays) but no later than 4pm on Friday 7 June 2024.

New applications to vote by post, and amendments or cancellations of existing postal votes or proxy vote arrangements must reach the Electoral Registration Officer at Electoral Services Office, 2<sup>nd</sup> Floor Civic Centre, Silver Street, EN1 3XA by 5pm on **Wednesday 19<sup>th</sup> June 2024**. Applications can be made online at **www.gov.uk/apply-postal-vote**.

8. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on **Wednesday 26 June 2024**.
